PEACEKEEPING OPERATIONS OFFICER

As a Peacekeeping Operations Officer, you help design, coordinate, and monitor international missions that support peace and security. You'll work with multiple UN bodies, including mission leadership, military and civilian components, and local governments, to ensure that missions meet their mandate goals. Key tasks include conflict mediation, assessing security and human rights risks, liaising with stakeholders, and adapting operations to evolving ground realities.

ECONOMIC AFFAIRS / DEVELOPMENT POLICY OFFICER

In this role, you support sustainable development by analyzing macroeconomic trends, advising governments or UN agencies on policy, preparing reports & recommendations, and helping integrate the UN 2030 Agenda into national and regional strategies. You work on topics like poverty reduction, inclusive growth, trade policy, and social protection, often collaborating across technical disciplines and geographic regions.

Why Global Engagement Matters for Tennessee

One of my passions is staying connected to the global conversations that shape our world. For more than 30 years, I've been involved with World Affairs Councils in different parts of the country, and I've seen firsthand how they enrich communities by making international issues accessible and relevant. In today's environment, those issues aren't abstract. They directly affect our local economy, our security, and our future leadership role among world nations. That's why the work of the Tennessee World Affairs Council (TNWAC) is so important to me.

Through TNWAC, Nashville (together with Knoxville and Memphis) has a forum for timely, thought-provoking dialogue. The Council convenes foreign policy experts, diplomats, business leaders, and others influencing our community, giving Tennesseans insights that are often only available in academic halls or major global cities. This opportunity keeps us well-informed and better prepared to understand how international developments connect to our lives here in Middle Tennessee. For me, staying engaged fuels my excitement for Global Nashville, a city defined not only by music and hospitality but increasingly by healthcare leadership and its role as a preferred destination for global companies, talent, and innovation.

The Council's upcoming programs illustrate this momentum. In October, Mike Honious, former President & Description of GEODIS Americas, will explore how resilient logistics systems fuel America's economy, security, and independence—and why supply chains are now a national priority. Soon after, CMA CEO Sarah Trahern will highlight how Nashville's signature cultural export is booming worldwide, strengthening our global brand and opening new opportunities for artists. And in November, Commissioner Stuart McWhorter will outline Tennessee's strategy for international investment, underscoring how state leadership, business, and community partners work together to make our state a trusted player on the global stage. Together, these conversations reveal the convergence of international logistics, cultural influence, and government strategy—all reinforcing Nashville's rise as a city of global consequence.

As a TNWAC board member, I've seen firsthand how these discussions strengthen our city's identity as a global hub and equip us to thrive in a world where the local and International are inseparably linked.

But this mission depends on support. TNWAC is a nonprofit, and its programs are possible only through the generosity of people who believe it matters for Tennessee to stay engaged globally. 
