

On January 1, 1892, 134 years ago, an Irish teenager named Annie Moore, accompanied by her younger brothers Anthony and Phillip, disembarked onto the brand-new Ellis Island Inspection Station in New York Harbor. The three youngsters planning to reunite with their parents were the pilot experiments for the Immigration Act of 1891. This act of Congress intended to federalize and regulate what had been up to that point an ad hoc and ultimately unsustainable immigration system. While Annie Moore endured a largely undistinguished existence, her legacy lives on with the approximately 40 percent of Americans whose lineage traces directly to 1 or more of the 12 million immigrants who were also processed on this tiny artificial island in New York Harbor.

These immigrants, primarily from Europe, had many reasons to permanently abandon their homelands and seek a brighter future on a new continent. Jews, both in the Russian Empire and also throughout Europe, had suffered centuries of persecution and were undeniably lured by America's constitutional guarantee of religious freedom. An even larger cohort of Catholic Italians, mostly from Southern Italy, and hampered by a lack of economic opportunity, also boarded ships bound for a new home with seemingly endless possibilities. They were joined by Poles, Greeks, Hungarians, Swedes—like my own Great-Great Grandparents—and more.

While each family had their own unique story, these largely impoverished Europeans knew they had no future in a repressive and rigidly hierarchical Europe. What was once a country predominantly descended from English Protestants was suddenly transformed into a melting pot. However, by the 1920s, American patience with these new arrivals was wearing thin. Public services and social cohesion in American cities had been stretched to the limit, to the point where an angry public demanded Congress act again. And in 1924, Congress did exactly that, passing the Johnson-Reed Act, which established quotas of 150,000 immigrants and put Ellis Island out of business for good, at least as an immigration processing facility. In 1965, following four decades of decay, President Lyndon Johnson incorporated Ellis Island into the Statue of Liberty National Monument until 1972 when it in New York Harbor was transitioned into its permanent status as the National Museum of Immigration. Now, as the United States grapples with a new variety of immigrant, hailing from faraway lands such as India, Iraq, and Ethiopia, let us not lose sight that our current immigration debate is nothing new, rather, it has been occurring since long before Annie Moore made her fateful disembarkation onto a tiny artificial island in New York Harbor.


